- a. This application is strictly for grade 6 contractors only.
- b. This form can be used for applying in more than one category and payments can be done under one receipt. Please attach a separate sheet where space on the form is limited for additional information.
- Please fill in the form completely as provided and bind it in spiral or better with all necessary attachments. Print clearly using ink.
   Incomplete and unbound applications will not be processed.
- d. All applicable fees must be paid directly to the National Council for Construction (NCC) through its Bank accounts as provided herein.
- e. Present the original Bank deposit slips/transmission copies to NCC for receipting.
- f. All applicable fees paid to the NCC are Non-refundable and Non-transferable. Electronic Bank transfers will only be receipted after two working days of the transfer and upon confirmation that the transfer has cleared.
- g. Any request for certificate replacement shall attract a fee. Further, certificate replacement as arising from changes in company name will attract a fee subject to approval by NCC.
- h. At least one of the shareholders for applicants applying for registration must have undergone formal training in a construction related field. Training should be minimum accredited certificate.
- i. Copies of all certificates attached must be "Certified True Copies of the original" and where applicable must be translated into English language.
- j. Applications can be done online using the NCC online portal https://portal.ncc.org.zm attaching all the necessary documents. Alternatively, submissions can be deposited at designated Regional Offices in Kitwe, Choma and Lusaka, whose addresses are indicated above.
- k. Ensure that your application for EXPRESS registration is scrutinized and approved by NCC before Express registration fees are paid. Express registration takes up to a maximum of 5 working days.
