- c. Please fill in the form completely as provided and bind it in spiral or better with all necessary attachments. Print clearly using ink. Incomplete and unbound applications will not be processed.
- d. All applicable fees must be paid directly to the National Council for Construction (NCC) through its Bank accounts as provided herein.
- e. Present the original Bank deposit slips/transmission copies to NCC upon which a receipt will be issued.
- f. All applicable fees paid to the NCC are Non-refundable and Non-transferable. Ensure that you meet all the requirement before you make any payment.
- g. Electronic Bank transfers will only be receipted upon confirmation.
- h. At least one of the shareholders or directors for applicants applying for registration must have undergone formal training in a construction related field. Training should be minimum accredited certificate.
